BOWLINE

All Over Washroom Cleaner

DIRECTIONS FOR USE

SHOWER & BATHROOM SCUM:

BOWLINE should be applied neat. Apply to bath or shower, allow a few minutes to penetrate dirt and soap scum, agitate and then rinse off.

SINKS, BENCHTOPS & FLOORS:

BOWLINE should be diluted 1 to 10.

Apply to surface, allow a few minutes to penetrate dirt, agitate with sponge and then rinse off.

TOILETS & URINALS:

BOWLINE should be applied neat to toilet bowl. Direct product inside bowl to completely coat the sides of the bowl and up and under the rim. Allow a few minutes to penetrate dirt, agitate and then rinse off.

MAINTENANCE

BOWLINE should be diluted 1 to 10. Apply to surface, allow a few minutes to penetrate dirt, agitate with sponge and then rinse off.
