4. FIRST AID MEASURES

6. ACCIDENTAL RELEASE MEASURES

SMALL SPILLS

7. HANDLING AND STORAGE

10. STABILITY AND REACTIVITY

Chemical stability: This material is thermally stable when stored and used as directed.

Hazardous decomposition products: Oxides of carbon and nitrogen, smoke and other toxic fumes.

Hazardous reactions: Solutions will corrode mild steel, lead, zinc & aluminium & will attack brass, copper & phosphor bronze. The material is stable but solutions slowly hydrolyse to form ammonium bisulphate particularly at elevated temperatures. Can react violently or explosively with metal nitrates or nitrites if heated, fuming nitric acid & chlorine gas
