### 4. FIRST AID MEASURES

### SMALL SPILLS

### LARGE SPILLS

Work up wind or increase ventilation. Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material). TWA - The time-weighted average airborne concentration over an eight-hour working day, for a five-day working week over an entire working life.

STEL (Short Term Exposure Limit) - the average airborne concentration over a 15 minute period which should not be exceeded at any time during a normal eight-hour workday.

These Exposure Standards are guides to be used in the control of occupational health hazards. All atmospheric contamination should be kept too as low a level as is workable. Do NOT enter confined spaces where vapour may have collected.

Wear safety shoes, overalls, gloves, safety glasses. Available information suggests that gloves made from should be suitable for intermittent contact. Wash contaminated clothing and other protective equipment before storing or re-using.
