DIRECTIONS FOR USE

CARPET SPOTTER :

FRESHEN should be diluted 1 to 5 parts in hot water, light spray over soiled area, leave for 5 minutes and work the stain towards the centre. Rinse with wetted cloth and allow to dry.

CARPET RESPRAY:

FRESHEN should be diluted 1 to 15 parts in hot water, prespray room, leave for 10 minutes. Rinse with hot water using extraction machine.
