Allow solution to flow freely through beer taps so that lines are properly filled. Leave for 30 minutes (preferably overnight) then flush beer lines with cool clean water. Drain water.

#### Glasses

Prepare a solution of LIQUID AMBER by adding 3ml of Part A and 3ml of Part B per litre of cool clean water and add to the dispenser in the glass washing machine.

**DO NOT MIX LIQUID AMBER PART A AND B TOGETHER IN THEIR CONCENTRATED FORM.**
