**Inhalation:** Remove victim from exposure to fresh air - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm and at rest until fully recovered. Seek medical advice if effects persist.

**Skin Contact:** If skin or hair contact occurs, immediately remove any contaminated clothing and wash skin and hair thoroughly with soap and running water. If swelling, redness, blistering or irritation occurs seek medical assistance.

**Eye contact:** If in eyes, wash out immediately with water, flushing continuously for at least 15 minutes with fresh running water. Ensure irrigation under eyelids by occasionally lifting upper and lower lids. In all cases of eye contamination it is a sensible precaution to seek medical advice.

**Ingestion:** DO NOT INDUCE VOMITING (to avoid aspiration). Rinse mouth with water. For small amounts give milk of magnesia or a glass or two of water or milk. For large quantities, get medical attention.

**Notes to physician:** Treat symptomatically. Effects may be delayed. Treat symptomatically. Delayed pulmonary oedema may result.

### 5. FIRE FIGHTING MEASURES

**Hazchem Code:** 3Y

**Suitable extinguishing media:** If material is involved in a fire use alcohol resistant foam, standard foam or dry agent (carbon dioxide, dry chemical powder).

**Specific hazards:** Flammable liquid and vapour. May form flammable vapour mixtures with air. Flameproof equipment necessary in area where this chemical is being used. Nearby equipment must be earthed. Electrical requirements for work area should be assessed according to AS3000. Vapour may travel a considerable distance to source of ignition and flash back. Avoid all ignition sources. All potential sources of ignition (open flames, pilot lights, furnaces, spark producing switches and electrical equipment etc) must be eliminated both in and near the work area. Do NOT smoke.

**Fire fighting further advice:** Heating can cause expansion or decomposition leading to violent rupture of containers. If safe to do so, remove containers from path of fire. Keep containers cool with water spray. On burning or decomposing may emit toxic fumes. Fire fighters to wear self-contained breathing apparatus and suitable protective clothing if risk of exposure to vapour or products of combustion or decomposition.

### 6. ACCIDENTAL RELEASE MEASURES

#### SMALL SPILLS

Wear protective equipment to prevent skin and eye contamination. Avoid inhalation of vapours or dust. Wipe up with absorbent (clean rag or paper towels). Collect and seal in properly labelled containers or drums for disposal.

#### LARGE SPILLS

If safe to do so, shut off all possible sources of ignition. Clear area of all unprotected personnel. Slippery when spilt. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contamination and the inhalation of vapours. Work up wind or increase ventilation. Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material). Use a spark-free shovel. Collect and seal in properly labelled containers or drums for disposal. If contamination of crops, sewers or waterways has occurred advise local emergency services.

### 7. HANDLING AND STORAGE

**Handling:** Avoid eye contact and skin contact. Avoid inhalation of vapour, mist or aerosols.

**Storage:** Store in a cool, dry, well-ventilated place and out of direct sunlight. Store away from foodstuffs. Store away from incompatible materials described in Section 10. Store away from sources of heat and/or ignition. Store locked up. Keep container standing upright. Keep containers closed when not in use - check regularly for leaks.

### 10. STABILITY AND REACTIVITY

**Chemical stability:** Autoxidation facilitated by light and air. Combustible material that has been soaked with d-Limonene may spontaneously combust. Peroxides formed by oxidation may present an explosion hazard if they become highly concentrated through distillation.

**Conditions to avoid:** Avoid heat, sparks, flames, direct sunlight, moisture, freezing, static charges, mechanical shock, high temperatures and other high energy ignition sources. Also avoid enclosed spaces.

**Incompatible materials:** Strong oxidizing agents, acid clays and mineral acids. Keep away from heat, sparks, open flames, hot surfaces.

**Hazardous decomposition products:** If the product is heated, it emits acrid smoke and fumes as well as CO and CO<sub>2</sub>.
